GTCFTC general meeting minutes, 6/25/2011

Because of a change in show times, the meeting was called ½ hour after Smooth Fox Terriers were shown. The time change involved Wires being shown 1 hour later at about 2:40 in the afternoon.

The minutes Of the last meeting were read and approved.

Show report: Elaine reported that Steve Baribeau has agreed to be the chief ring steward. Colleen will do the Hospitality and also function as the outside steward. All paperwork has been done and turned in and things seem to be going well. She reported that the Airedale club had contacted her about a gift for Katerina, our Russian Judge and that they were wondering if we would like to share in the cost of a gift of original artwork featuring chickens, which are another passion of our judge. The cost would be \$100. The motion was made, seconded and passed that we pay \$100 for the judge's gift. Discussion followed about the cost of other judges gifts and general consensus agreed that Dr. Boozer receive \$50, our sweeps judges receive \$25 and the obedience judge, Karen Anderson receive \$50. Colleen also reported that the board, while meeting at Fargo, had approved the hire of a show chair for 2017. She is Sandy McCord and has had considerable experience as show chair for the Cocker club and other specialties she lead. Her cost is \$200 and she wants the board to select the committees and to give her a list of terrier judges they would like. Since judges are not always available and since we also have to work with SCVKC the list should be long. Colleen asked that the members confirm this decision and that was passed.

Job Descriptions Elaine reported on a book of job descriptions that is provided by the AKC. Her report was enthusiastically received by the members.
